Re-Notification for Appointment of President of Board of Governors, IPE

Indian Institute of Petroleum and Energy (IPE) has been established by an Act of Parliament in the year 2017. IPE is an autonomous Institute of National Importance under the administrative control of Ministry of Petroleum and Natural Gas, Govt. of India. It is established, along the lines of IITs and IIMs with the objective to provide world class education, training to nurture and promote quality and excellence in education and research in the area of petroleum and hydrocarbons and energy to meet the growing requirements of the Petroleum & Energy sector. IPE is co-promoted by six leading Oil Public Sector Units (ONGC, IOCL, OIL, GAIL, BPCL and HPCL) in association with the OIIB. IPE has started its academic operations from the academic year 2016-17 onwards and presently 4th year students are completing their final year by the end of 2019-20 academic year, i.e. 1st Batch of B.Tech. Degree holders releasing by the IPE with these students.

IPE is presently operating at Andhra University College of Engineering Campus at Visakhapatnam. IPE was allotted around 200 acres of land at Vangali village, Sabbavaram Mandal, Visakhapatnam district for establishing its permanent campus there and efforts are being made to construct main campus with world class technology there. IPE presently offers programs at Undergraduate courses – i.e. B.Tech. (Chemical Engineering) and B.Tech. (Petroleum Engineering). Post Graduate and Doctoral level programs in the domain of i) petroleum and ii) chemical engineering are expected to be offered from 2020-21 academic year onwards.

The Search Committee invites applications for the position of President, Board of Governors of IPE. The applicants should fulfil the following criteria :

Candidate, need to have gained distinction in his professional life and preferably have academic, research or operational experience in the broad domain of petroleum technology including energy and hydrocarbon development.

In addition, he should be an individual who has true understanding of the nature of professional education and commands public confidence. **The position of President, Board of Governors is purely honorary and non-remunerative in nature.**

ROLE AND RESPONSIBILITIES:

- a. The President, Board of Governors shall be ex-officio Chairman/ President of IIPE Board of Governors and Finance Committee and member of IIPE General Council.
- b. He shall preside at the meetings of Board of Governors, Finance Committee and at the Convocations of the Institute.
- c. He shall convene the meetings of Board of Governors and Finance Committee as per provisions made in the Statute in consultation with Director.
- d. The President - BoG shall exercise such other powers and perform such other duties as may be assigned to him by IIPE Act or the Statutes.

TENURE & AGE FOR THE POST:

The President, Board of Governors shall hold office for a term of three years. The applicant should not be more than 67 years of age at the time of application.

SELECTION PROCESS:

The President, Board of Governors shall be appointed by the Competent Authority based on the recommendation made by the Search Committee, which will consider applications received in response to this advertisement, as well as nominations received from eminent persons. Those who had applied earlier in response to the IIPE Advt dt 3rd June 2019 need not apply. Those nominations received earlier sent by eminent persons will be considered as such.

HOW TO APPLY:

Interested individuals may apply giving their detailed resume, clearly bringing out research, teaching, industry-academia collaborations and administrative achievement, along-with a justification in support of their candidature in not more than 500 words along with a vision statement for the Institute and reference details of at least two distinguished individuals well acquainted with their work.
