RULES AND REGULATIONS:

COMPETITION DURATION:

- 1. THE COMPETITION WILL RUN FOR 5 DAYS.
- 2. START DATE: 11TH OCTOBER 2023 AT 9:00 A.M.
- 3. END DATE: 15TH OCTOBER 2023 AT 9:00 A.M.
- 4. PARTICIPANTS CAN TRADE FREELY DURING THIS PERIOD.

VIRTUAL PORTFOLIO:

- 1. EACH PARTICIPANT WILL RECEIVE A VIRTUAL PORTFOLIO WITH \$50,000 IN FUNDS.
- 2. NO ADDING OR WITHDRAWING OF FUNDS IS ALLOWED DURING THE COMPETITION.

CRYPTOCURRENCIES:

- 1. PARTICIPANTS CAN ONLY TRADE CRYPTOCURRENCIES LISTED IN THE COMPETITION.
- 2. TRADING ANY OTHER CRYPTOCURRENCIES OR ASSETS IS PROHIBITED.

MARKET DATA:

- 1. PARTICIPANTS WILL HAVE ACCESS TO REAL-TIME MARKET DATA.
- 2. ANALYSIS TOOLS WILL BE AVAILABLE TO MONITOR PORTFOLIO PERFORMANCE AND MAKE INFORMED TRADING DECISIONS.

TRADING RESTRICTIONS:

- 1. MARGIN OR LEVERAGE TRADING IS NOT PERMITTED.
- 2. SHORT SELLING AND ADVANCED TRADING STRATEGIES ARE PROHIBITED.
- 3. ALL TRADES MUST BE EXECUTED WITHIN THE VIRTUAL PORTFOLIO PROVIDED.

SCORING:

- 1. THE WINNER WILL BE DETERMINED BY THE HIGHEST PORTFOLIO VALUE AT THE COMPETITION'S END.
- 2. PORTFOLIO VALUE IS CALCULATED AS THE SUM OF CASH AND THE CURRENT VALUE OF ALL HELD CRYPTOCURRENCIES.

PRIZES:

- 1. THE WINNER WILL RECEIVE A CASH PRIZE (PRIZE AMOUNT IS SURORISE, MORE THAN 25K).
- 2. TOP-PERFORMING PARTICIPANTS WILL RECEIVE ADDITIONAL PRIZES.
- 3. THE PRIZE MONEY WILL BE GIVEN TO THE PERSON WHO HAS REGISTERED AT THE SHASWAT WEBSITE.
