## **Terms & Conditions**

- 1. Scrutiny/Selection committee of IIPE Visakhapatnam reserves the right to fix suitable criteria for short-listing of eligible candidates.
- 2. Candidates will be shortlisted for the interview based on merit and experience of the available candidates. Short-listed candidates will be notified for interview and decision of selection committee will be final.
- 3. The date and time of interview will be informed by email to candidates and hence a valid email ID should be provided by the candidate in the application.
- 4. Qualification should be from a recognised University. Mere fulfilling of essential qualification does not guarantee for interview call or selection.
- 5. Eligibility and age will be considered as on the last date of application.
- 6. Candidates should furnish original certificates at the time of interview & joining.
- 7. The post to be filled up only on purely temporary basis and is co-terminus with the project.
- 8. The engagement can be terminated at any time by giving one-month notice on either side. The recruited staff's engagement can be terminated forthwith or before expiry of the notice period by making payment of a sum equivalent to one-month amount.
