Terms and Conditions

- 1. Scrutiny/selection committee of IIPE Visakhapatnam reserves the rights to fix suitable criteria for short listing of eligible candidates
- 2. Candidates will be shortlisted for the interview based on merit and suitable experience of the available candidates. Shortlisted/Selected candidates will be notified for interview and decision of selection committee. Please note that decision of selection committee will be final.
- 3. The date, time, venue and mode of interview (online/offline) will be informed by email only to short listed candidates. Hence, a valid email ID should be provided by the candidate in the application
- 4. Qualification should be from a recognized university. Mere fulfilling of essential qualification does not guarantee for interview call or selection.
- 5. Eligibility and age will be considered as on the last date of application.
- 6. Incomplete application form without requisite information, certificates/documents, is liable to be rejected.
- 7. Candidates should furnish all original certificates, signed application form, accompanied with selfattested photocopies of all the requisite certificates, mark sheet in support of age, educational qualifications, experience (if any), at the time of interview and joining
- 8. False or fake information detected at any point of time will lead to cancellation/termination of the candidature without assigning any reason.
