1. Scrutiny/Selection committee of IPE Visakhapatnam reserves the right to fix suitable criteria for short-listing of eligible candidates.
2. Candidates will be shortlisted for the interview based on merit and experience of the available candidates. Short-listed candidates will be notified for interview and decision of selection committee will be final.
3. The date and time of interview will be informed by email to candidates and hence a valid email ID should be provided by the candidate in the application.
4. Qualification should be from a recognised University. Mere fulfilling of essential qualification does not guarantee for interview call or selection.
5. Eligibility and age will be considered as on the last date of application.
6. Candidates should furnish original certificates at the time of interview & joining.
7. The post to be filled up only on purely temporary basis and is co-terminus with the project.
8. The engagement can be terminated at any time by giving one-month notice on either side. The recruited staff's engagement can be terminated forthwith or before expiry of the notice period by making payment of a sum equivalent to one-month amount.
