- (i) Call Letter (will be forwarded separately to the registered email of the eligible candidates);
- (ii) Original and valid Photo Identity Proof (PAN/ Driving License/ Voter Id/ Passport/ Aadhar Card (with Photograph)) along with xerox copy;
- (iii) Duly filled COVID-19 Self Declaration Form (will be forwarded along with Call Letter);
- (iv) Test Report for COVID-19, conducted on or after 30.08.2021 with COVID-19 Negative result;
- (v) Any other document(s) as mentioned in the Call letter;

If any candidate is found at any subsequent stage or at the time of Trade Test/ Skill Test any information given by him/her or any claim made by them in their application, is found to be false, their candidature will be liable to be rejected and will not be allowed for any further consideration.

Candidates must wear a mask and follow the COVID-19 appropriate behaviour at all times whilst attending for the Written Examination.
