Note for provisionally shortlisted applicants:

1.1 The above applicants are shortlisted for the next stage of selection purely based on the information provided by the candidates. 1.2 The onus is on the candidates that the information submitted during application process is correct and to produce all the documents in original for document verification to prove their claim about their eligibility including Date of Birth, category (if applicable), income (if applicable), nature of being physically challenged (if applicable), service in the armed forces (if applicable), education, professional certification (if applicable), experience certificates by their employers for all the experience relevant to the post, etc.

1.3 The candidates are required to submit the **No Objection Certificate (NoC)** at the time of Interview, if applicable.

1.4 If the candidate is not able to produce all the relevant documents in the original form for document verification, and/or if the information provided by the candidate is found to be untrue, the candidature stands automatically cancelled without any notice. Applicants are advised to visit the institute website regularly for further updates.

1.5 As per the advertisement, the selection process for the post of Deputy Registrar, is as follows:

1.6 The Written Test and Computer Proficiency Test will be qualifying in nature and their marks will not be accounted for the preparation of final merit. The Committee constituted to conduct the Written Test and Computer Proficiency Test will decide the minimum qualifying marks for each i.e. Written & Computer Proficiency Test individually. Only the candidates who qualify in Written Test will be allowed to attend the Computer Proficiency Test.

1.7 The candidates who qualify in both Written Test and Computer Proficiency Test individually will be called for Presentation & Interview. The final selection will be solely based on Presentation and Interview before the Selection Committee.

1.8 The Written Test and Computer Proficiency Test for the shortlisted candidates will be conducted on **22.11.2025** (Saturday). The out-station shortlisted candidates are advised to book the tickets accordingly at their own cost.

1.9 The date of Interview for the candidates who qualify in the Written Test and Computer Proficiency Test, will be intimated separately.
