## Annexure - I



#### **ADDITIONAL TERMS & CONDITIONS**

- **Installation & Testing:** The installation shall be completed within 15 days from the date of award of the Contract.
- 2. IIPE Visakhapatnam is registered with Dept. of Scientific & Industrial Research, Govt. of India and concessional customs duty is leviable vide notification No.51/96-Customs dated 23.07.1996.
- 3. **Terms of Payment:** Within 15 days of receipt of the bill/invoice, full payment will be made on duly recommended by user on receipt & Installation of material at IIPE. **No advance payment will be made.**
- 4. **Performance Bank Guarantee (PBG):** Vendor shall furnish Performance Bank Guarantee for 10% of order value, which shall be covered for the period which includes delivery, installation and warranty + 60 days. This PBG will be refunded to the vendor only on satisfactory completion of all contract obligations as per tender and Purchase Order. The PBG is required to be submitted within 30 days from the order acknowledgement/delivery date whichever is earlier.
- 5. All the documents as per the PAC notice are to be submitted after duly certified by the authorized signatories.
- 6. **Liquidated Damages:** In case of delayed delivery, prices will be reduced at 0.5 % of the total basic value for every week of delay or part thereof subject to a maximum of 10 % of the total basic order value.

### 7. Public Procurement (Preference to Make in India), Order 2017:

- (a) IIPE Visakhapatnam shall compare all substantially responsive bids to determine the lowest valuated bid. This Institute is following and abide with the Public Procurement (Preference to Make in India), Order 2017, DIPP, MoCI Order No. P-45021/2/2017B.E. II dated 15th June 2017 and its subsequent amendments. Accordingly, preference will be given to the Make in India products while evaluating the bids, however, it is the sole responsibility of the bidder(s) to specify the product quoted by them is of Make in India product along with respective documentary evidence as stipulated in the aforesaid order in the technical bid itself.
- (b) As per the above order and its subsequent amendments "Local Content" means the amount of value added in India which shall be value of the item procured (excluding net domestic indirect taxes) minus the value of the imported content in the item (including all the custom duties) as a proportion of the total value, in percent. Accordingly, the suppliers will be classified in following categories.
- (c) As per the OM of Department of Promotion for Industry and Internal Trade No. P-45021/102/2019-BE-II-Part (1) dated: 04.03.2021. The bidders can't claim themselves as Class-I local suppliers/Class-II local suppliers by claiming the services such as transportation, insurance, installation, commissioning, training and after sales service support like AMC/CMC etc. as local value addition.
  - (i) **Class- I local Supplier**: A supplier or service provider, whose goods, services or works offered for procurement, has local content equal to or more than 50% as defined under this order.
  - (ii) Class -II local Supplier: A supplier or service provider, whose goods, services or works offered for procurement, has minimum local content of 20% but less than 50%, as defined under this order.
- (d) **Verification of Local Content:** The Class -I Local Supplier/ Class -II Local Supplier at the time of bidding shall be required to indicate the percentage of local content and provide self-certification that the items offered meet the local content requirement. The details of the location(s) at which the local value addition is made also needs to be specified. In case of procurement in excess of Rs.10 Crores, the suppliers

shall be required to provide the certificate from the statutory auditor or cost auditor of the company giving the percentage of local content.

The bidders can be debarred for a period up to two years as per Rule 151(iii) of GFR 2017, in case of false declaration.

- **8.Requirement of registration:** With reference to Ministry of Finance (MoF) OM No. 6/18/2019-PPD dated 23rd July 2020: -
- (a) Any bidder from a country sharing a land border with India will be eligible to bid in this tender only if the bidder is registered with the Department for Promotion of Industry and Internal Trade (DPIIT).
- (b) "Bidder" (including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.
- (c) "Bidder" from a country which shares a land border with India" for the purpose of this Order means:
- (i) An entity incorporated, established or registered in such a country; or
- (ii) A subsidiary of an entity incorporated, established or registered in such a country; or
- (iii) An entity substantially controlled through entities incorporated, established or registered in such a country; or
- (iv) An entity whose beneficial owner is situated in such a country; or
- (v) An Indian (or other) agent of such an entity; or
- (vi) A natural person who is a citizen of such a country; or
- (vii) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above

For details about registration procedures please visit the above-mentioned OM. Mandatory documentary evidence regarding the bidder's registration with DPIIT is to be submitted along with the tender, failing which the tender shall be liable for rejection. Bidders are also requested to submit the Model Certificates **as per Annexure** for this tender as mentioned in the Ministry of Finance OM No. 6/18/2019-PPD dated 23rd July 2020.

- 9. Director of IIPE Visakhapatnam may accept or reject any quotation in part of full without assigning any reason and does not bind himself to accept the lowest bid or cancel this process at any time, without assigning any reason whatsoever. The Institute at its discretion may change the quantity/ upgrade the criteria/ drop any item or part thereof at any time before placing the Purchase Order.
- 10.In case of any disputes, the decision of the Director of this Institute shall be final and binding on the Bidders.
- 11. **Jurisdiction**: The disputes, legal matters, court matters, if any, shall be subject to Visakhapatnam, Andhra Pradesh Jurisdiction only.
