## r.w.r 18AAA of the I.T. Rule, 1962.

In exercise of the powers conferred by the sub-clause (iiif) of sub-section 2(a) of Section 80G of the Income-tax Act, 1961 (43 of 1961), the prescribed authority hereby notifies **Indian Institute of Petroleum and Energy** as an Institute of National Eminence, for the purposes of the said sub-clause, subject to the following conditions namely:-

(iii) A copy of accounts of each accounting year shall be submitted to the prescribed authority by the 31<sup>st</sup> December next following the last date of accounting year.
