- In the event of my involvement in any activity outside the Institute, which is punishable by the law of the land, the institute shall in no way provide any support to me and will be not be responsible either for my action.
- **I am aware of the meaning of 'Ragging' as defined by Supreme Court, that:**  
"Ragging is any disorderly conduct, whether by words spoken or written, or by an act which has the affect of teasing, treating or handling with rudeness any student, indulging in rowdy or indiscipline activities which cause or are likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the psyche of a fresher or a junior student".
- I am also aware that, in case of myself indulging/involving in the act of ragging I am liable for punishment(s) noted hereunder as per the graveness of the offence.  
Cancellation of admission, (2) Suspension from attending classes, (3) Withholding / withdrawing scholarship / fellowship and other benefits, (4) Debarring from appearing for any test / examination or other evaluation process, (5) Withholding results, (6) Debarring from representing the Institution in any National or International Meet, Tournament, Youth festival, etc., (7) Suspension, expulsion from the hostel, (8) Rustication from the Institution for periods varying from 1 to 2 academic years, (9) Expulsion from the Institution and consequent debarring from admission to any other Institution, (10) Fine up to Rs.50,000/-, (11) Rigorous imprisonment up to three years (by Court of Law) etc. under ragging act 26 of 1997 and vide G.O.M.S. No: 67 dated: 31-08-2002.
- It may be noted that as per the Supreme Court order dt: 16-05-2009 in SLP No. 24295/04, "It is mandatory for the Institution, where the incident of ragging is reported, to file a First Information Report (F.I.R) before the local Police authorities and such reports also be made to the Civil Authorities and Higher Police authorities for taking necessary action in the matter."
- I am also aware that students will not be allowed to hold / use any electronics devices like Mobiles / Cameras etc., other than the permitted ones in the classrooms / examination hall / laboratories or any other areas, which are specified for the purpose. I am aware that hence in case I am found violating this and found using mobile, the concerned faculty / or the officials of IIPE have the right to confiscate the instrument / device thus used and or impose such penalty and or punishment as felt appropriate by respective authority.
- I also declare that I am not suffering from any serious/contagious ailment including psychology related symptoms.
