APPOINTMENT OF DIRECTOR

Indian Institute of Petroleum and Energy (IIPE), a domain specific institute in the petroleum and energy sector, set up by Government of India, Ministry of Petroleum and Natural Gas in Visakhapatnam (Andhra Pradesh), invites applications for the post of Director from candidates possessing PhD with first class or equivalent at the preceding degree in the appropriate branch in Petroleum, Chemical Engineering or Geology and other related fields with an outstanding academic record throughout and a minimum of 10 years' experience as a Professor in a reputed educational institute equivalent to IITs and should have guided Ph.D Students. The Director of IIPE is the academic and administrative head of the institute. He/she is expected to have a minimum of 5 years' administrative experience and leadership qualities to head an Institute of National Importance. The applicant should not be more than 65 years of age, preferably be less than 60 years of age on the last date of receipt of the applications. The post carries a fixed pay of Rs. 2,25,000/per month, with applicable allowances.

Indian Institute of Petroleum and Energy (IIPE) is established by the Government of India, under the aegis of the Ministry of Petroleum and Natural Gas, in the year 2016 at Visakhapatnam as per the provisions made in the Andhra Pradesh Reorganisation Act, 2014. The Indian Institute of Petroleum and Energy Act, 2017 (No.3 of 2018) which is enacted by the Parliament declares it as an *Institute of National Importance*. The main objective of establishing IIPE is to meet the quantitative and qualitative gap and supply of skilled manpower for petroleum and energy sectors and to boost the research activities needed for growth of sectors by nurturing and promoting the quality and excellence in education and research in the area of petroleum and hydrocarbons and energy. The Government of Andhra Pradesh has allotted 200 acres of land at Vangali village, Sabbavaram Mandal, Visakhapatnam for setting up of permanent campus for IIPE. IIPE is presently operating its academic activities from the temporary campus situated at Andhra University College of Engineering, Visakhapatnam.

The selection will be done on the basis of interview/ exam of the shortlisted

candidates. The appointment will be made on contractual basis for a period of five years

or till attainment of 70 years of age, whichever is earlier, as per usual terms and conditions.

Interested individuals may apply giving their detailed resume in the prescribed

format clearly bringing out research, teaching, industry-academia collaborations and

administrative achievements, along with a two-page justifications in support of their

candidature, a two page vision statement for the institute and contact details of at least

two distinguished individuals well acquainted with their work. The application typed in the

prescribed format along with enclosures may be sent by Registered/ Speed Post to "The
