The total income of the family from all sources for the financial year 2024-25 will be considered for remission of the Tuition Fee for the academic year 2025-26. The students whose family income is not more than Rs. 5 lakhs per annum are eligible to apply. The students whose family income is less than Rs. 1 lakh per annum shall get full remission of the Tuition Fee and whose family income is between Rs. 1 lakh to Rs. 5 lakhs per annum shall get remission of $2/3^{rd}$ of the Tuition fee.

Eligibility Criteria: - Remission of Tuition Fee.

- 1. Annual Family Income (**Gross, before any deductions/ exemptions under the provisions of income tax etc.**) from all sources should not be more than Rs. 5,00,000/- (Rs. Five Lakh only) for availing Tuition Fee Waiver.
