Minister calls for coal gasification technology

The Union Steel Minis Mr. ter, Ram Chandra Prasad Singh recently chaired a meeting with the stakeholders from the steel industry, CSIR-Central Institute of Mining and Fuel Research (CIMFR) to deliberate on the prospects of using coal gasification in steel production through the Direct Reduced Iron (DRI) route.

The Steel Minister emphasised the need for development of indigenous coal gasification technology which is suited for the indigenously produced coal. Mr. Singh urged the stakeholders to come together in development of the technology which can be gainfully utilised by the steel industry and help in reducing the dependence of imported and promote "Atmanirbhar Bharat".

Discussions were held on the present scenario and the way forward for



promoting coal gasification in the steel sector. V a r i o u s Coal Gasification Technologies commercially available, their pros & cons, and their suitability for Indian high-ash noncoking coal were discussed. Development of Indigenous Technology for coal gasification along with technologies for recovery of the by-products for applications in the various

sectors such as chemicals, fuels, fertilisers etc. were also discussed.

As per an official release the 'Dwarf' containers provide a 67% increase in volume when doublestacked and can carry a weight of 71 tons, against 40 tons by an ISO container. In addition, Indian Railways has offered 17% discount on haulage cost



compared to double stack ISO container trains, resulting in an overall 33% discount to shippers making Indian Railways competitive. Thus the rail movement of cargo through Dwarf containers has the potential to lower the EXIM logistics

> costs, making Indian exports globally competitive.
